6. ELIGIBILITY/QUALIFYING REQUIREMENTS

The child/ward of an applicant is eligible for consideration of a scholarship award if:

- i) The applicant has been admitted as a member for a period of twenty-four (24) continuous months prior to the time of application
- ii) The applicant has been in good financial standing particularly in respect of all loan accounts held with the Civil Service Co-operative Credit Union and saving has been consistent for a period of twenty- four (24) months prior to the time of application.

Awards will be granted on a competitive basis as follows:

- i) The candidate qualifies for admission to an appropriate local secondary or local tertiary level educational institution as the case may be on the basis of academic performance in the year of application.
- ii) The candidate has obtained the highest aggregate marks at the Common Entrance Examinations or an assessment by the Society on the basis of grades of individual subjects taken at CXC examinations and the candidate is adjudged on a whole to be the highest academic achiever.
